On Thursday, January 27th, 2011 at 5:38 pm, John Owens, President of the Sabine Neches Chief's Association called to order the 1st Quarter Board of Directors Meeting held at the Schooner.

Open Meeting: Noting that a Quorum was present, President Owens opened the meeting.

Old Business:

President Owens had Chief Steve Curran give an update on the work being done on the SNCA website by Juxtapose. Chief Curran advised members Juxtapose was moving along on the development and showed the progress on his laptop. Some board members asked about having certain information password protected, mainly having to do with the SNCA inventory information. President Owens also stated that Vernon Pierce was very interested in getting the SNCA inventory on the site, and making it possible for members to log in and do their updates online. Discussion also followed to have a member of the organization be appointed as the Web Administrator to oversee the operation of the web site.

A motion was made by Tim Ocnaschek to allow the President to appoint a member of the organization as the Web Administrator, and his/her duties would be to oversee and coordinate with the IT vendor. The motion was seconded by Terry Basham, motion carried.

President Owens appointed Chief Steve Curran to be the SNCA Web Administrator.

The President called for a motion to approve the Treasurers Report; Cindy Powers made the motion to approve the Financials and Terry Basham seconded the motion. The motion carried.

A discussion followed regarding members who were delinquent in dues payments for 2011. Various Board Members volunteered to contact these members. A discussion followed in how membership could pay dues with a credit card or online through some avenue such as "Paypal". Chief Curran stated he would discuss this with the IT vendors who are setting up the web site, and get back with the board on possible ways this can be accomplished online.

New Business:

President Owens discussed a request from Marshal Jeff Wilmore, with the Groves Police Department, to appoint Pastor Turner, with St. Paul Lutheran Church, as Chaplain of the organization. A discussion

followed and the board members felt the request needed to be looked at by the constitution committee. Board members agreed Pastor Turner could be designated as an honorary member at this time.

A motion was made by Tommy Wells, and seconded by Ann Huff to designate Pastor Turner as an honorary member of the SNCA. Motion carried

A motion was made by Tim Ocnaschek and seconded by Vernon Pierce to have the constitution and By-laws committee look at creating a position in the SNCA organization for Chaplain, and to define the roles and authority of the position. Motion carried.

President Owens opened up discussion of the SNCA golf tournament, and to solicit assistance from members of the board. President Owens turned the floor over to Stephanie Garsea, who informed members she still needed help with door prizes and food vendors. Stephanie also stated she would continue to promote the tournament, and ask members to solicit teams and hole sponsors.

President Owens opened discussion regarding the State's and COG's priority for future grant funding being allocated to "Interoperability". President Owens discussed the importance for the SNCA be involved in Homeland Security planning for the region. A motion was made by Vernon Pierce and seconded by Stephanie Garsea, to devote the next Strategic Planning meeting to allow the membership input into identifying the Homeland Security priorities for the region. Motion carried.

Elgin Browning commented on efforts being made in the region to coordinate training to eliminate Elgin also commented on the BEST school which will soon be advertised. duplication in schools. Board members discussed the SNCA class which was held at the Elegante' Hotel. Board members were not impressed by the turnout on Friday, and there was discussion made that if the SNCA was going to participate in the next school, a request would be made to move the class to a day earlier in the week. Some board members questioned the cost for participation in the school, which was \$715. Elgin reminded members the charges were from the hotel, and not BEST. Another discussion followed regarding the use of the SNCA logo on flyers and advertisements in the previous year's school. There were some concerns that the use of the logo might have been without the approval of the SNCA membership. Noting that currently there were no rules or procedures outlined in the Constitution and By-laws for use of the SNCA logo, a motion was made by Cindy Powers and seconded by Aleta Cappen to not lend the SNCA logo to any entity or organization without the investigation and approval of the Board of Directors, and to be subsequently voted on by SNCA membership. Any request to use the SNCA logo would need to be made in writing to the president of the SNCA for consideration. Motion carried.
