#### OLD BUSINESS:

President Owens reminded the membership of the LIT "Salute to Real American Heroes" banquet is to be held on September 6, 2012 at the Wesley United Methodist Church located at 3810 North Major Drive, in Beaumont. President Owens also advised the membership he had a few tickets available if anyone was interested in going to the event.

#### **NEW BUSINESS:**

A request was received from Chief Singletary with the Beaumont Police Department for participation in the 2012 Cops–n-Kids Carnival set for Saturday September 15, 2012. President Owens had an electronic vote sent out to Board members in regards to partnering with the event, by making a donation of \$2,000. There was 100% approval from the BOD to do the \$2,000 sponsorship for this worthwhile event. President Owens asked for discussion on the request, and hearing none asked for a motion from the membership. David Frenzel made a motion for the SNCA to donate \$2,000 to the Cops-n-Kids Carnival to be held in Beaumont, the motion was seconded by Mike Free. The motion carried.

Chief Jeff Wilmore has been working on getting information on insurance for the Mercy Trailer. As you all are aware, the trailer is now an asset of the SNCA, and the title to the trailer has been put in the SNCA name. The trailer is a 2006 Keystone Springdale model 298 trailer which was donated by TOTAL, and it is valued at \$9,600. Chief Wilmore inquired about the cost of insuring the trailer, which was quoted at around \$597.00 per year. Terry Schwertner with McFerrin Insurance provided the quote, and offered to donate the cost of insuring the SNCA Mercy trailer. Terry is also a Council member in the City of Port Neches. An electronic vote was conducted with Board Members on accepting the offer to pick up the annual cost for insuring the trailer. President Owens opened the floor for discussion, and hearing none asked for a motion from the membership. Larry Richard made a motion to accept the gracious offer from Mr. Schwertner and McFerrin Insurance for the offer to donate the insurance cost to cover the mercy trailer. Larry also asked that a letter of thank you be sent to Mr. Schwertner for his kind donation. The motion was seconded by Aleta Cappen, Motion carried.
