# **MARCH 2014 MINUTES**

# Quorum is (10) Voting Members at Regular Meeting

The 774<sup>th</sup> Sabine Neches Chiefs Association meeting was called to order at 10:13 a.m. on Wednesday, March 5<sup>th</sup>, 2014 at Big Rich Courville's at 1744 Rose Lane #90, Beaumont, TX 77713.

Cindy Powers gave the invocation.

Mike Free led the Pledge of Allegiance.

The welcome was presented by Jeff Thibodeaux with East Texas Regional Advisory Council and he introduced the SETRAC Board members who accomanied him.

Self Introduction were made.

The following SNCA Officers were excused: Dale Jackson, Charlie Kosh, Jeff Wilmore, and Jeff Kelley

#### **READING OF THE MINUTES**

President Owens asked for "Approval" of the previous month's minutes as e-mailed. A motion was made by Stephanie Garsea and seconded by Cindy Powers to approve the minutes. Motion carried.

#### **CORRESPONDENCE:**

Membership request from 24 Hr Safety and sponsorship letter from Nederland Fire Chief/EMC Gary Collins. (Letters attached)

Membership request from KMTEX and sponsorship letter from Beaumont Police Department/EMC Tim Ocnaschek. (Letters attached)

## **Continuation of Correspondence:**

Email from Scott Kerwood asking for volunteer evaluators for their annual 3-day CBRNE drill at the Hutto Fire Department. He is interested in hazmat, fire and LE functions and provided his contact information if anyone is interested.

The accounting firm of Edgar Kiker and Cross has completed its annual compilation of the Sabine Neches Chiefs' Association financial statements. The accountant's engagement is not an audit and the Compilation Report and Financial Statements cannot be relied upon as such; however, the engagement letter does provide that the firm "will inform the appropriate level of management of any material errors, and of any evidence or information that comes to our attention during the performance of our compilation procedures, that fraud may have occurred." The Compilation Report does not note any evidence of material errors or fraud. One item of note is that expenses slightly exceeded income during calendar 2013 (\$597.56). The new budget process agreed upon by membership should provide more detailed oversight for future expenditures. A copy of the annual report is on file with the Secretary/Treasurer.

The Sabine Neches Chiefs' Association has filed its 2013 annual 990 E-post card information return with the IRS and acceptance of the return has been acknowledged by the IRS by way of email. The 990 E-post card return is the appropriate return for an income tax-exempt organization which does not normally have receipts of more than \$50,000.

#### TREASURERS REPORT:

The Treasurer's information is presented with the assistance of Deputy Fire Chief John Avery, PAFD.

The financial report was read by Secretary/Treasurer Tim Ocnaschek. A motion was made by Aleta Cappen and seconded by Chris Gonzales to accept the financial report. Motion carried. Renewable Biofuels (2013 pro rata dues and 2014 dues) and Pinehurst Fire are the only two members left with outstanding dues.

#### **OLD BUSINESS:**

In the February 5th motion to approve Beaumont Water Utilities as an SNCA member, it was accidentally addressed as a non-voting member. The Board requests a motion to change their membership from a non-voting member to a voting member in line with the Constitution eligibility and original Board recommendation and evote. That motion was made by Bryant Champagne and seconded by David Frenzel. Motion carried.

#### **NEW BUSINESS:**

On 2/13/2014, an e-vote was conducted by the SNCA Board resulting in a recommendation to membership that 24 Hr Safety's membership request be approved. The Board further concurred with the Membership Committee recommendation that they be identified as a non-voting vendor/sales company in line with Constitutional

eligibility and membership requirements. This application has Nederland Fire Chief/EMC Gary Collins' sponsorship. Correspondence was read as noted previously. Tommy Wells made a motion that 24 Hr Safety be accepted into SNCA membership as a non-voting vendor/sales company. Larry Mannino seconded that motion. Motion passed. Blayne Forman with 24 Hr Safety was present at the meeting and was congratulated by President Owens on becoming a member.

On 2/27/2014, an e-vote was conducted by the SNCA Board resulting in a recommendation to membership that the KMTEX membership request be approved. The Board further concurred with the Membership Committee recommendation that they be accepted as a non-voting pipeline/storage facility member in line with Constitutional eligibility and membership requirements. This application has Beaumont Police Lieutenant/EMC Tim Ocnaschek's sponsorship. Correspondence was read as previously noted. Cindy Powers made a motion that KMTEX be accepted into SNCA membership as a non-voting pipeline/storage facility. Aleta Cappen seconded that motion. Motion carried.

The Beaumont Fire Department will be hosting a Youth Firesetting Prevention & Intervention Program, Level I on March 11-12, 2014 at the Beaumont EOC. Class will be approximately 8am-5pm each day. Jamie Perkins of the State Fire Marshal's Office will be teaching the 2 day class and a course manual will be provided. This class will be offered as a professional development course to fire department personnel. Please call or email Jeff McNeel (jmcneel@ci.beaumont.tx.us) if you are interested in the course. A description of the class follows below:

#### NATIONAL FIRE ACADEMY

#### YOUTH FIRESETTING PREVENTION & INTERVENTION PROGRAM

#### **LEVEL-I**

(Previously known as: Juvenile Firesetting Intervention Program, Specialist I)

This two-day course is based on the requirements of NFPA Standard 1035 pertaining to the Youth Firesetting Intervention Specialist Level I. Students will be empowered with a broad understanding of the knowledge, skills, and abilities the Youth Firesetting Intervention Specialist I should meet as requirements of NFPA Standard 1035 pertaining to youth firesetting. The Level I intervention specialists provide services at the program delivery level. They help identify firesetters, conduct program intakes, provide screenings to identify risks of future firesetting, deliver educational interventions, perform follow-ups, and evaluate program services.

Target audience for this course is anyone who has worked (or will be working) with youth who are exhibiting firesetting behaviors, and is appropriate for volunteer and career firefighters, Fire Marshals, fire investigators, Fire and Life Safety Educators (FLSEs), and allied professionals from criminal justice, mental health, social services and juvenile justice.

#### Course covers the following:

- · Review of the NFPA 1035 Standard for Youth Firesetting Intervention Specialist I.
- · Extent of youth firesetting problem and justification for local youth firesetting prevention and intervention programs.
- · Examination of the typologies of firesetting and the motivation behind firesetting behaviors.
- · Identification, intake, screening, disposition, and follow-up.
- · Youth firesetting educational interventions.

#### Completion of the course student will be able to:

- Explain national trends in youth firesetting and compare those trends to the statistics from their home communities.
- · Classify the typologies of youth firesetting.
- · Explain intervention options to mitigate youth firesetting behavior.
- · Present an educational intervention for a Youth Firesetting Prevention and Intervention Program.
