The 795<sup>th</sup> Sabine Neches Chiefs Association meeting was called to order by President Dale Jackson, at 10:10 a.m. Wednesday, December 2, 2015, at Big Rich Courvilles, Beaumont. The event was sponsored by Hayden and Company.
