#### **NEW BUSINESS:**

A. President Jackson discussed with the group about sending Steve Curran and Pat Grimes to the Texas Homeland Security Conference.

Together the costs associated with Steve Curran and Pat Grimes attendance to the Texas Homeland Security Conference in April. The total amount for both will be \$1,900, with Steve's room, meals, registration come out to \$800. Pat's expenses for room, parking, meals, registration, and travel come out to \$1,100. Pat's is more because he is driving and Steve is riding with someone else. Both of them are available for the conference. I understand the current budget does not allow for these expenses, so it was propose to take \$1,900 out of our general bank account to pay these expenses. The plan is to take the money from the \$40,000 plus, in the general account so it should not be an issue. President Jackson expressed that having these two guys there to make the classes and represent the SNCA interests is well worth the money.

A motion was made by Gary Collins to amend the budget by \$1900 and to use that money to send Steve and Pat to the conference. The motion was seconded by John Owens. The motion passed by vote.
