New Business:

- A. Bryant Champagne discussed a membership request for Beaumont Information Technologies Department. They were sponsored by Tim Ocnaschek and the Beaumont Police Department as a member in good standing. Bryant made a motion that Beaumont IT Department be accepted as a government entity, voting member. The motion was seconded by Larry Richard to accept the Beaumont IT Department as a government entity, voting member. The motion passed by vote.
- B. Bryant Champagne discussed a membership request for Foster Enterprises. They were sponsored by Glen Lyles and ExxonMobil as a member in good standing Bryant made a motion that Foster Enterprises be accepted as a vendor/sales entity and non-voting member. - E. Stephanie Garsea asked for ideas to increase donations for the next golf tournament. Carman Apple suggested a \$5 buy-ahead option. In general, board members felt the team cost was high enough to encourage member participation. No action taken.
- F. Tim Ocnaschek discussed and made a motion that SNCA sponsor Pat Grimes to attend the State ETN committee meeting scheduled for August 2, 2016. It would involve the cost of a hotel for one night at the State rate. John Owens seconded the motion. Motion passed by vote.

Other Business:

Steve Curran has updated the website with the latest changes to the Constitution and will make updates to the membership roster once updates are made. Pat Grimes agreed to cross-check the database with the membership roster to validate the primary and alternate members for each entity.
