NEW BUSINESS:

A. Tim Ocnaschek discussed the board's discussion by e-vote to recommend the membership approve support of HB 919. Tim then discussed the following:

As the IMT Steering Committee member for Region 2, I have been working with the Brazos Valley IMT, TFS, and Representative Kacal's office reference this House Bill. You can read the executive summary and bill in the attachment, but for our area, it would be most beneficial for the retirees we have who still wish to maintain their IMT credentials and would still be valuable to our region and team if an incident develops where we are stretched thin. We have several who have stayed on the team into retirement, one of whom is a Logistics Section Chief Train-the-Trainer. My hope would be that we can develop and then maintain self-sufficiency in position specific training ability for SETRPC. Right now we only have a couple positions covered for instructor level trainers. It would also be nice to have a local source of heavily experienced personnel to assist the DDC/DC (Carman) or one of our EOCs if we need support for an incident in our own jurisdictions. Worker's Comp coverage enabled by this bill would protect them if they get injured if they are activated from a State of Texas Assistance Request (STAR).

As the IMT committee chair for the Association, I think there is benefit for us to lend official support to this bill through our local legislators and am doing so from the jurisdictional level. As the SNCA President, I ask if you think this is beneficial for the Association and if so, is there a motion and second that we could send out for an E-Vote to the Board. Since the Legislature is in session and things are moving rapidly, we will be behind the curve if we wait until the next Board meeting to discuss. Please advise.

A motion was made by Louis Havens and a second by Ricky Bodin to support HB 919. Motion carried.
