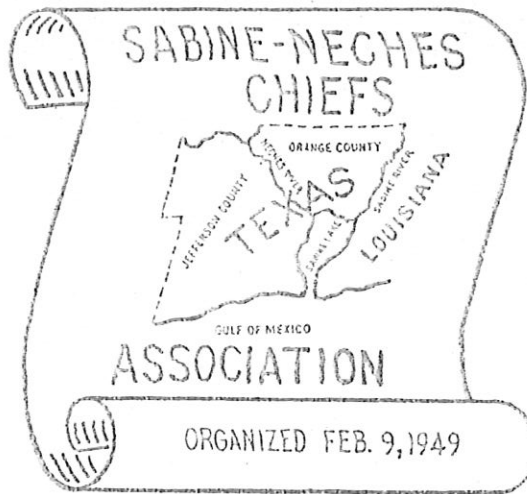

Bill Roe reported on a visit to the southwest Louisiana Mutual Aid Group meeting in Sulphur. Bill gave a talk on the news media during emergencies.


Pete Shelton talked on how important it is for industry to let municipal fire departments know what is inside their plants.

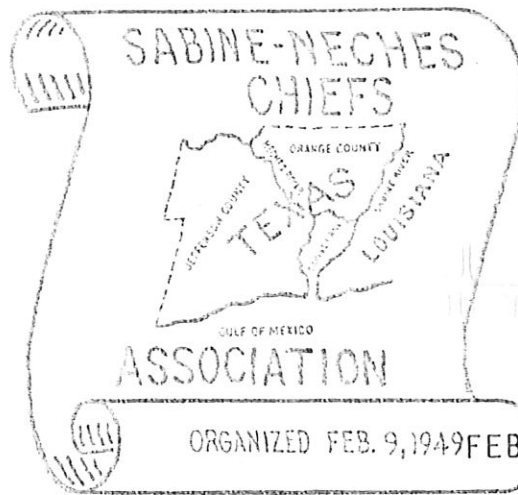

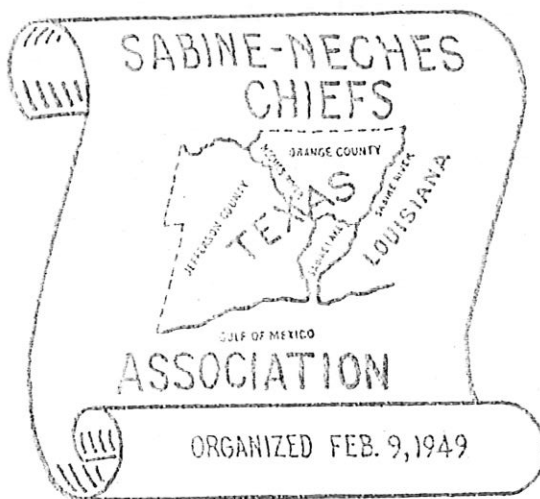


Orange County Civil Defense is now back in the Sabine Neches Chiefs Association. They will host the November meeting.

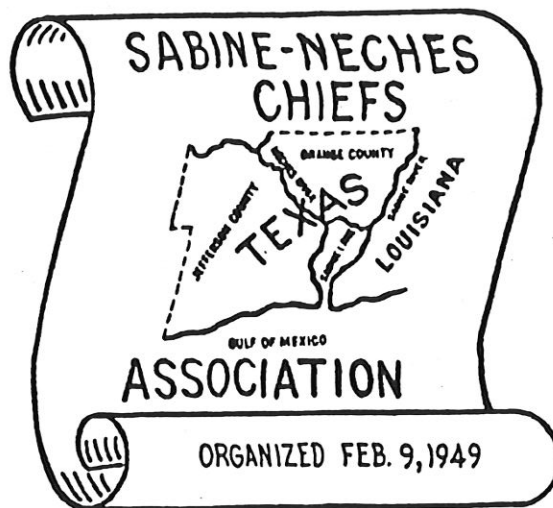

A safety and fire equipment supply company with local facilities. Represented by James Butch England - Associate Membership.

A letter from Robert L. Swarthout, Fire Chief, City of Houston, was read requesting support for their bid for the annual State Firemens' and Fire Marshals' Association Conference/Convention for the year 1990.

Whitehead discussed the needed update and revision of the communication chart. Currently it has non-functioning organizations listed and some are listed under Associate Member that should be under full member.

Pete Shelton reported that 138 students are registered for the 16th Annual Fire School scheduled for 4/29 thru 5/3. He reported all is ready, all preparations complete and the grounds are in good shape except for some last minute touch-up to be done on a designated work day on April 20, 1985. Pete also reminded all instructors of a "party" at the Gray Institute on Tuesday night April 30 and a fish fry given by Arthur Dooley and Sons on Wednesday night, May 1, 1985. (P. S.) Joe Wiley will cook gumbo for the work day on April 20.

Chuck Wheeler reported that piling was being moved in for developing the Hazardous Material School, but it will not be ready by the Annual Fire School. Wheeler also reported that a hearing to render final approval for the waste water handling permit was scheduled for April 9, 1985 and all were hopeful it would be approved.

Scott, Lamar University, reported a busy month for April and that on April 8, 1985 a rookie fire school class of 23 would graduate at Lamar. He reported no volunteer school would be held in April because of the annual fire school coming up.

Don Isenberg, current Director of the Jefferson County Red Cross was introduced and he indicated continued strong support of the Red Cross.

Louis Miller gave a brief summary of the Audit Committee activity and recommended approval of the report. The Audit Committee will meet as a Committee to generate detailed procedure recommendation at a later date. A motion was made by Bob Wood, seconded by Curtis Holden to delete the 2 cent error in the Fire Boat Account and accept the Bank Statement balance as true and recordable. All voted approval. (Thanks from your "Treasurer - Grady Baldwin for this vote of trust.)

Tommy May reported on the 3rd Annual Traumatology Drill simulated during March and participated in by local (Beaumont Fire Department, law enforcement and the Du Pont Beaumont Works. All reported a good learning process.

Bridge City coordinated with West Orange in a simulated emergency conducted at the West Orange Jr. High School, West Orange responded and Bridge City was called in for back up.

Commander Robinson, Coast Guard, announced that a special award presentation will be made on May 7 by Admiral Stewart in which the "Distinguished Service Award", the highest award made by the Coast Guard to a "civilian" will be made and that this organization will be especially pleased in this award. The award will be presented at a luncheon to be held at the Pompano Club at 11:15 A.M. on May 7, 1985.

A special program concerning the activities and responsibilities of the Coast Guard Strike Team stationed in Mobile, Alabama was introduced by Tommy May. Operation Officer Lt. John Farthing and Chief Warrant Officer Riley Byrd presented an excellent program on Hazardous Material Control, Containment and Clean Up.

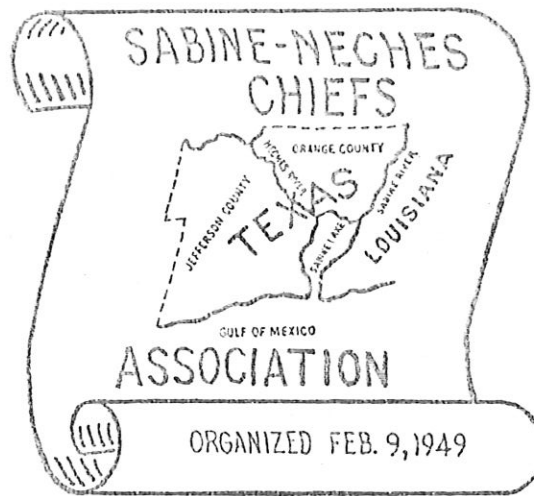

Emergencies-Recent emergencies were discussed.




Pat Gallagher, Sunoco introduced Glen LeLeaux - his replacement. Pat is moving to Longview. All wish him well.



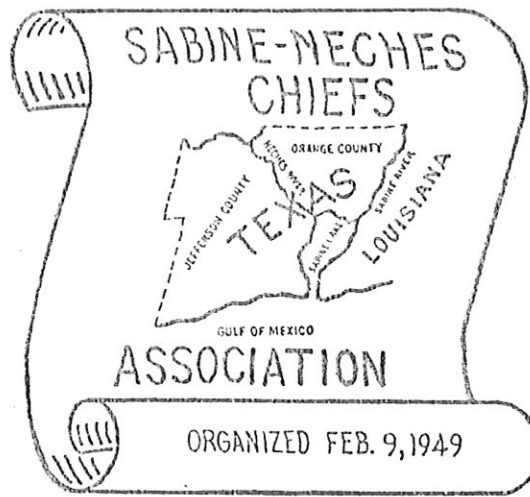

Board members. Many changes to the chart are necessary because of changes in the business and economic structure of the two counties and the chart is sorely in need of drastic review and updating. Bob Whitehead will discuss the plan with the membership in an open meeting.

Jack McClelland reported that he had been discussing the organization with the areas various law enforcement groups and was encouraged by their stated renewed interest and support for the organization and indicated that representatives will be attending the meetings more regularly.

To emphasis the need for all organizations in the area to work together in an emergency, Bob Whitehead suggested that the organization invite each law enforcement organization in the association area to designate and send one member of their organization to the annual fire school free of charge. In discussion it was recognized the only out-of-pocket cost to the organization would be the cost of the noon meal each day and the gain would be in having law enforcement personnel better acquainted with the activity of the fire organization and better prepared to assist by improved understanding and direction of the public. Grady Baldwin made a motion we follow the suggested plan. Bob Wood seconded the motion, the vote was unanimous to do so.

Other Business:

A letter requesting support and assistance from fire service personnel in the area in voting with the City of Houston's application to host the 1990 State Firemens and Fire Marshals' Association Conference/Convention. This application will be submitted for vote at the 1985 Annual Convention to be held in Waco, Texas this coming June.
