





ARTICLE II

SECTION 3

Associate Membership - the representative of a governmental agency, vendor, supplier and others engaged in fire and police related activities that are not qualified for active membership may become Associate Members under the following conditions:

- a. Agencies of businesses and etc. must have offices and/or operations in the Triangle Area.
- b. Acceptance into Association will not exceed 18 Active Membership.
- c. Comply with Section 7 of Article II.
- d. Failure to participate or attend meetings will be cause for removal from membership.

Associate Members shall have the privileges of an Active Member, except for voting and holding offices.

RECOMMENDED REVISION:

SECTION 3

Associate Membership - the representative of a vendor or supplier and others engaged in fire and police related activities that are not qualified for active membership may become Associate Members providing they comply with the following conditions:

- a. Company or agency must have offices and/or operations in the Triangle Area and support the total effort of the Association.
- b. Acceptance into Association will not exceed 12 members.
- c. Comply with Section 7 of Article II.
- d. Failure to participate or attend meetings will be cause for removal from membership.

Community Service Membership - the representative of a governmental or community service agency that are not qualified or have provisions

for active membership and will not be assessed fees or dues (such as American Red Cross, Salvation Army, National Weather Service, U.S. Coast Guard, Lamar University, Regional Liaison Officer, etc.) and comply with the following conditions:

- a. Agencies or organizations must have offices or operations in the Triangle Area (Jefferson or Orange Counties).
- b. Must support the total effort of the Association.
- c. Community Service Members shall have the privileges of an Active Member, except for voting and holding offices.

ARTICLE III

Section 1

The elected officers of the Association shall consist of a President, a Vice-President, a Secretary-Treasurer, and a Board of Directors, consisting of two members each representing municipal fire protection, industrial fire protection, and from public law enforcement agencies.

At the first election of officers in December, 1967, three members of the Board of Directors will be elected for three years, and three members will be elected for two years. This will provide the Association with a rotating staff of directors rather than six new members each election. Officers shall serve two year terms starting January 1, 1968. They shall not be elected to the same office for more than two consecutive terms. (Exception: Three directors for the first election.)

RECOMMENDED REVISION:

The elected officers of the Association shall consist of a President, a Vice-President, a Secretary-Treasurer, and a seven-member Board of Directors consisting of two members from municipal fire protection, two members from industrial fire protection, two members from law enforcement agencies, and one member at-large (this one member at-large must comply with Article II Section II).

ARTICLE IV

Duties of Officers

Section 4

Duties of the Board of Directors: This shall consist of two members from municipal fire protection, two from industrial fire protection, and two from law enforcement agencies. They shall serve two years, until their successors have been elected. They shall not be elected more than two consecutive terms. Their duties shall be to serve on the Executive Board as representatives of their respective groups. They shall also perform any duty assigned them by the President.



RECIPROCAL AID AGREEMENT WITH OTHER MUTUAL AID ORGANIZATIONS ALONG THE TEXAS GULF COAST ADOPTED APRIL 25, 1961 REVISED MARCH 10, 1989

<u>PURPOSE</u>

This agreement is intended to clarify methods and procedures to employ in obtaining emergency aid by and from the Mutual Aid Organizations listed below:

Texas City Industrial Mutual Aid System.....Texas City

Refinery Terminals Fire Company......Corpus Christi

Sabine-Neches Chiefs Association......Beaumont

The intent of this agreement is to provide assistance in the form of equipment, supplies, and/or manpower to another mutual aid organization who is acting under the authority of the management of their respective member who is experiencing the emergency situation.

DEFINITIONS

Subscriber - The mutual aid organization as listed above.

Member - Any entity belonging to a mutual aid organization listed above.

METHOD FOR ACTIVATION

The above subscribers agree that when an emergency occurs in an area of any individual subscriber and the local resources are inadequate to control that emergency, the authorized representative of the affected subscriber, upon authorization by the member in the emergency, may request activation of this reciprocal aid agreement.

The authorized representative of the subscriber requesting assistance shall contact the lending subscriber(s) as outlined in Appendix 1.

	•	

AGREEMENT

A request for equipment, supplies and/or manpower originating from the authorized representative of the affected subscriber at the request of the member in emergency shall be the binding agreement between the member in the emergency and the responding subscriber or subscriber's member.

The member in emergency agrees to replace material used, and to repair or replace equipment lost or damaged in the control of a fire or emergency situation within its facilities in cash at current prices, or in kind, provided the equipment and/or supplies were furnished by a subscriber or subscriber's member in response to a properly placed request. Damage to and loss of equipment refers to damage and loss as a direct result of the emergency condition rather than from the wear and tear expected in normal operation of emergency equipment.

The member in emergency is responsible for documenting equipment and supplies for the purposes of reimbursement.

Reimbursement for costs associated with manpower will be per the lending subscriber's respective provisions.

This agreement cannot be implemented by a third party for-hire contractor, nor will it continue to be in effect after the respective member experiencing the emergency contracts incident command to a for-hire contractor. Contracting for incident command, with subsequent cancellation of the provisions of this agreement, does not release the subscriber's member from reimbursement provisions committed to prior to the suspension of application of this agreement.

Appendix I

To Activate the Reciprocal Aid Agreement the following information shall be provided when requesting assistance:

- 1. Requesting individual name and company or subscriber name
- 2. Call back telephone number
- 3. Nature of emergency
- 4. Location of emergency
- 5. Member in emergency
- 6. Authorizing representative of member in emergency
- 7. Specific resources requested
- 8. Reporting point and recommended travel routes
- 9. Contact at reporting point
- 10. Means of contacting Command Post (e.g. cellular phone number, common radio frequencies, etc.)







TOXNET DEFINED

TOXNET is a computerized system of toxicologically oriented data banks operated by the National Library of Medicine in parallel with the Library's ELHILL system. This mini-computer based system includes a variety of modules used by the Library and its contractors to build and review records. For outside users, TOXNET offers a sophisticated search and retrieval package which permits efficient access to valuable data, drawn from numerous sources, on potentially toxic or otherwise hazardous chemicals.

HSDB

Hazardous Substances Data Bank

A scientifically reviewed and edited data bank containing chemical and toxicological information strengthened with additional data related to environmental fate/exposure potential, emergency handling procedures, and regulatory requirements. Data are derived from a variety of books, monographs, and open scientific literature sources as well as other publications including government documents and special reports. All data statements in each HSDB record are referenced and peer reviewed. This file currently contains records for nearly 4200 chemical substances.

RTECS

Registry of Toxic Effects of Chemical Substances


This file is produced and maintained by the National Institute for Occupational Safety and Health. It presents acute and chronic toxicity data including: skin and eye irritation, general toxicity, reproductive effects, carcinogenicity, and mutagenicity. RTECS also covers regulatory and test status. It contains records for approximately 91,000 chemical substances.

CCRIS

Chemical Carcinogenesis Research Information System

Sponsored by the National Cancer Institute, this file contains evaluated data and information, derived from both short and long-term bioassays, on 1200 chemical substances. Studies relate to carcinogens, mutagens, turnous proporties, co-carcinogens, metabolites and inhibitors of carcinogens, etc.

HSDB DEFINED HSDB is a factual, non-bibliographic data bank focusing upon the toxicology of potentially hazardous chemicals. It is enhanced with data from such related areas as emergency handling procedures, environmental fate, human exposure, detection methods, and regulatory requirements. Data are derived from a core set of standard texts and monographs, government documents, technical reports and the primary journal literature. HSDB contains complete references for all data sources utilized. HSDB is fully peer reviewed by the Scientific Review Panel (SRP), a committee of experts drawn from the major subject disciplines within the data bank's scope. The file is being built, maintained, reviewed, and updated on the National Library of Medicine's (NLM) Toxicology Data Network (TOXNET). HSDB is organized by chemical record, with nearly 4200 chemical substance records contained in the file.
