





March Board of Directors Meeting:

President Bruce informed the membership of the development involving the City of Beaumont Fire Training Grounds. Lamar University has a sizeable cash outlay resulting from the announcement of the annual Industrial Fire Training Program. To protect this cash expenditure in the event something unforeseen occurs causing this training to be cancelled, the 1994 contract indicated the Sabine Neches Chiefs' Association be responsible for the monies spent. In view of the fact the Sabine Neches Chiefs' Association receives no monetary gain from this or any of the other classes held at the City of Beaumont Fire Grounds, President Bruce recommended to the membership that the contract with Lamar University not be signed by the Sabine Neches Chiefs' Association. The SNCA will continue to endorse and support the City of Beaumont Fire Training Grounds and its programs, but discontinue joint sponsorship of the school. Through a vote of the membership, the Sabine Neches Chiefs' Association will not accept financial responsibility of Lamar University in the event the Industrial School is cancelled and will discontinue joint sponsorship of this school.

Beaumont Fire Chief Pete Shelton advised that the City of Beaumont would assume financial responsibility and sign the contract with Lamar University assuming this responsibility in the event the school is cancelled.

Vice President Mike Lovelady, Chairman of the By-Laws Committee will amend the by-laws to reflect the change.

John Davis, Halliburton NUS Environmental Corporation discussed the impact of the EPA RMP on Emergency Management and Emergency Preparedness:


