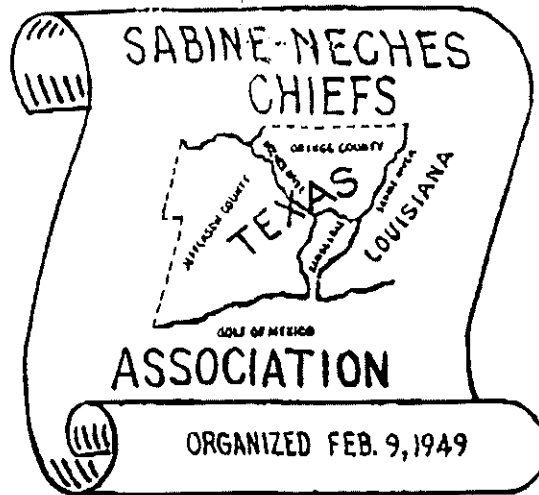

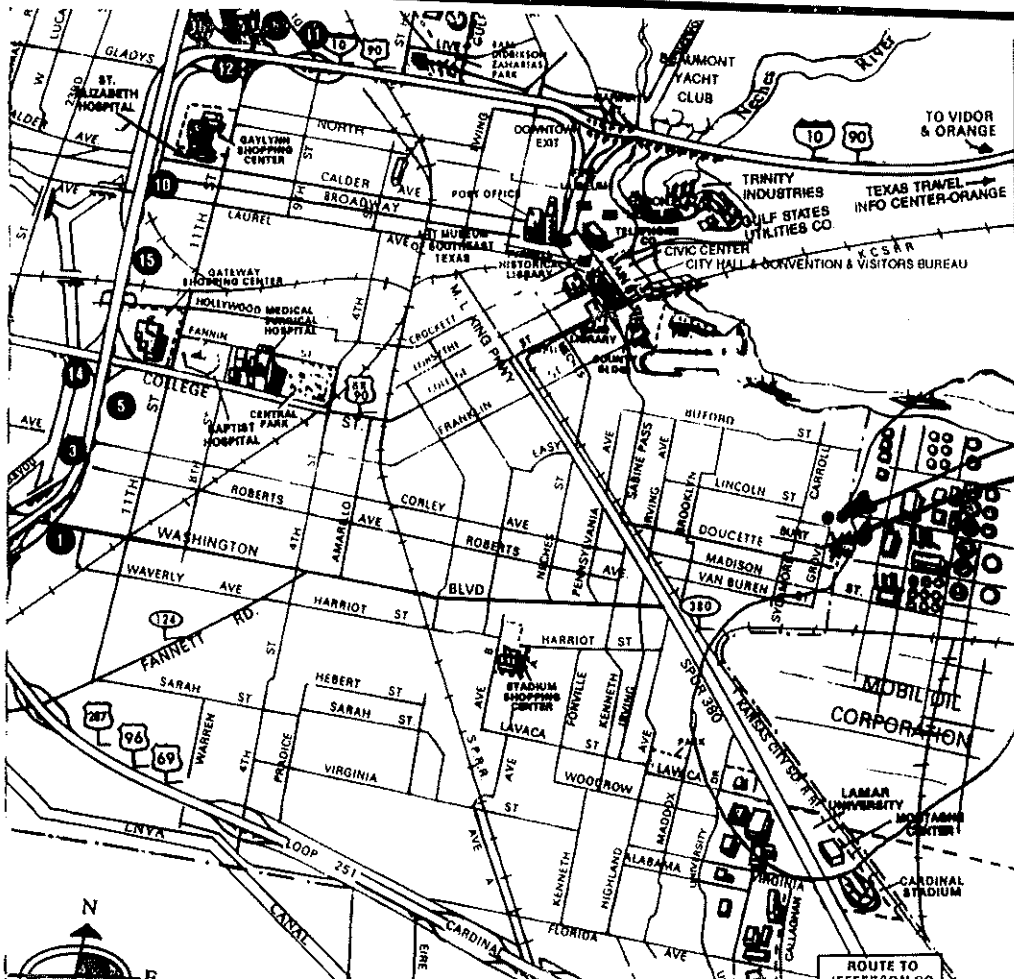
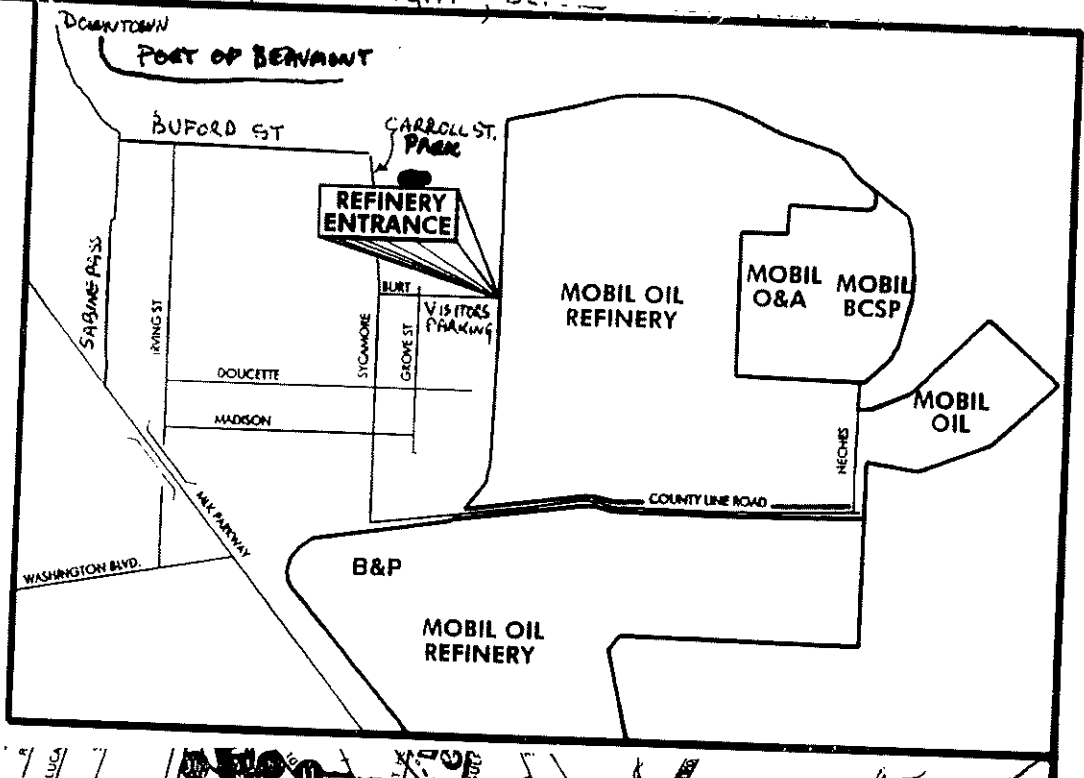
Invocation was given by Robbie Cloud.

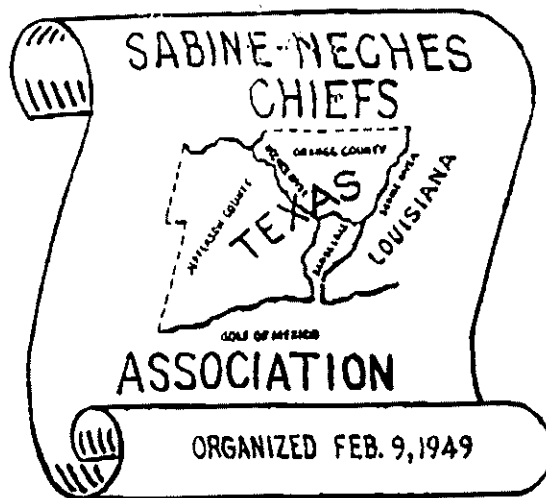

Fred Hoffman reminded everyone of Fireman's Appreciation day March 15 in Austin.



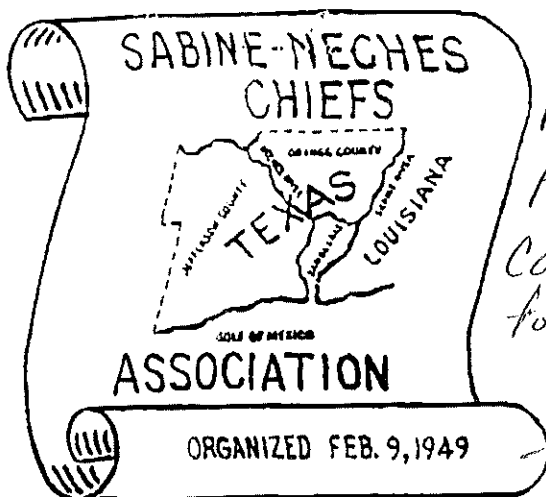

The membership request for Trans Star EMS services will be reviewed at the next Board Meeting (4/13, 6:00 p.m., Schooner Nederland).

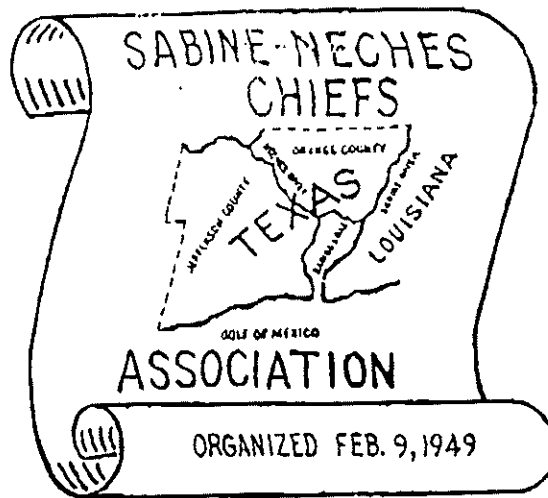


- Paying requirements for all who enter area considering business owners not involved & vendors with booths.
