## **CORRESPONDENCE:**

President Ocnaschek provided an explanation regarding Jasper County ESD#4 and that agency wanting to join the Association. JCESD#4 is a Board which oversee six departments in Jasper County but is not a response agency itself. Just recently Beech Grove Volunteer FD was voted into the Association however they are one of the agencies overseen by JCESD#4. Per the SNCA Constitution there cannot be two voting members from the same organization. After discussion with JCESD#4 President and Beech Grove Fire Chief it was decided that Beech Grove would withdraw its membership and JCESD#4 would become the agency to join the Association.

Following the above explanation President Ocnaschek asked for a motion to withdraw Beech Grove Volunteer FD from the Association. A motion was made by Mark Czerwiec to withdraw Beech Grove VFD and seconded by Louie Havens (PAFD). There was no opposition to the motion, motion passed.

Please accept this letter of request for membership for Jasper County Emergency Services District 4 (JCESD 4) into the Sabine Neches Chiefs Association. JCESD 4 is located in the northern half of Jasper County, providing services to approximately 20,000 permanent residents of northern Jasper County. Our coverage area is over 400 square miles. Within our district are Sam Rayburn Reservoir, B.A. Steinhagen (Dam B) Reservoir, Angelina National Forest, many campgrounds and parks, and thousands of weekenders with part time homes.

JCESD 4 contracts with six volunteer fire departments to provide fire, rescue, and FRO medical coverage within their defined territories. The contracted volunteer fire departments are as follows:

Jasper VFD East End VFD Lake Rayburn VFD Angelina River VFD Tri-Community VFD Beech Grove VFD

In addition and in partnership with the City of Jasper, we are contracted with Allegiance Mobile Health for emergency medical services.

In all, contracted VFD's average a cumulative total of over 1,000 calls per year. In combination with the City of Jasper, Allegiance Mobile Health averages 7,000 calls per year for emergency medical services.
