



The other point was that it was a period of time before the release to the waterways was noticed and this would be a good time to review our procedures to ensure prompt checking of valving or other ways for discharge into the waterways.

Special Announcements:

Dick Nugent announced that on August 31, 1987, House Bill 911 took effect. Southeast Texas Regional Planning is responsible for Jefferson, Hardin, and Orange Counties. A plan must be submitted by September 30, 1989. At this time, Jefferson County will be divided into four regions for 911 emergency call-in. The Sabine Neches Chiefs Association will be kept abreast of all changes and proposed changes in the emergency reporting as we have it now.

Pete Shelton announced that the Beaumont Fire Department is building a smoke-buster for rapid ventilation of building fires. It is expected that the smoke-buster will be able to move an excess of 97,000 C.F.M. of air when it is in operation. A rookie recruit school has started at Lamar. The area fire chiefs have worked to upgrade this school to make it an academy that the area will be proud of. The visitors dining area will hopefully be ready in time for the Lamar school.







The meeting was adjourned at 12:00 Noon.



Audit Committee's Report to the Sabine-Neches Chiefs Association Board of Directors

The Audit Committee met on two different occasions for the purpose of auditing the financial and general activities of the associations records for the 1987 fiscal year ending December 31.

The committee consists of Chairman - W. E. Roe, members Erskine Leysath, Louis Miller, ex-officio members: Robert Stegall, G. C. Baldwin and Ed Harris.

The audit committee found this years audit to be one of the better audits of the years we have been auditing the records. The areas covered in this years audit were: financial records, membership records, and other related matters of the general association as well as the financial records of the fireboat fund.

Although the records were in generally good order, several comments and/or recommendations were made for your information and edification.

General Fund

The General Fund was in good order and balanced with money spent and money collected. Again as was the case last year, very few checks were written.

Recommendations

- 1. The General Fund records were not provided to the audit committee until sometime in May and after examination were found to be incomplete and not until July were we given enough information to conduct our audit. We do recognize the fact that there was an office change which explained some of the problems but we feel that the secretary must be instructed to provide the necessary records no later than February of each year and that the audit committee complete its work so the board can act on recommendations no later than March of each year.
- 2. An accurate membership roster showing dues paid or not paid wasn't available and we would recommend that the list be updated when located and that it contain dues paid information.

- 3. The committee could not tell if any designated gifts were given to be used on a special project. ie: Haz-mat, etc. but we feel that we must honor the wishes of those who designated their gifts by keeping track of how these gifts were given and see to it that records show that designated funds were truly spent on the projects they were meant for. We do feel that any interest from the gifts can and should be used as any un-designated funds would be.
- 4. We again must recommend that the board should bond the people handling our money. This would protect the money handlers but also protect the board should something happen which would place us in a situation that could damage our organization.
- 5. The committee was pleased to see that our checking account is now interest bearing. We commend the secretary and board for their action in this area.

Fire Boat Fund

The records were found to be in good order and were received early in the year but couldn't be acted upon until the general accounts report was completed. All deposits balanced with expenditures and again as last year, very few checks were written.

Recommendations

- 1. Recommended that this account be consolidated into the general interest bearing account but accounted for seperately. There is no real need to maintain a seperate account any longer. Only three checks were written during the year and no deposits were made. The money left in the account should be transferred into the general fund and the principal should be used for only Fire Boat activities while the interest can be used for any general fund use.
- 2. Should you not decide to combine the accounts, we recommend that the money handler be bonded as has been recommended in past years.

Recap:

Again as was the case last year, all statements when finally received were very good and accurate. We want to thank all of those who made our job easier and without their dedication and effort the audit committee would have had a difficult time auditing the records.
