



#### FIRE FIELD EVOLUTION STUDENTS

Fire Field Evolution is divided into two segments: field work, conducted at the Fire Training Grounds, and conference sessions, conducted at the John Gray Institute and the Montagne Center, both located on the campus of Lamar University-Beaumont. (See map for location of these sites.) Information packets will be mailed to students as registrations are received; your first day reporting location will be designated in your packet. Personnel from each company or organization will be trained together at the same site each day. You should report at your designated first day site on Monday, May 13, 1991, at 7:30 a.m. You should bring protective firefighting clothing and gear as follows:

A. Firefighters helmet with face shield and chin strap; earflaps or hood recommended

B. Knee-length firefighter's coat with vapor liner (no rubber or plastic) and 3/4 length boots

C. Short coat and bunker pants

D. Gloves: cotten canvas or Nomex type (no rubber or plastic)

E. Students enrolled in courses requiring the use of SCBAs will be required to comply with the following policy:

Participants' facial hair must meet OSHA requirements for wearing SCBAs. Beards or long sideburns in the seal may cause seal failure.

Students not complying will not be allowed to participate in exercises requiring the use of SCBAs.

NOTE: Suitable clothing for hard work is mandatory, i.e., pants that touch the top of shoes and shirts with sleeves. No tee/tank tops or shorts will be allowed.

#### INDUSTRIAL RESCUE STUDENTS

Please report to the Fire Training Grounds on Monday, May 13, 1991, at 7:30 a.m. You will need to bring the following equipment: hard hat, eye protection, heavy work gloves, sturdy shoes or boots, bunker gear, rain protection gear and a small notebook with pencil/pen.

#### HAZARDOUS MATERIALS STUDENTS

Please report to the Fire Training Grounds on Monday, May 13, 1991, at 7:30 a.m. Bring notebook, pencil/pen and hard hat.

All students will attend the Friday morning conference session held at the Montagne Center at 8:00 a.m. The map in this brochure is for your convenience in locating training and meeting locations and hotel/motel accommodations.



Ed Harris introduced Jack Flynn from the host organization, Merichem. Jack then introduced the site superintendent, Greg McKnight who explained Merichem's acquisition of the old Independent Refining site in Winnie.

Self introductions were made.

The minutes of the 502nd meeting were read and approved with the following changes:

- 1. The date of the workday before the annual fire school will be May 4, 1991.
- 2. David McMillian was the Boeing Petroleum representative at the last meeting not David Morrison.
- 3. The SNCA members will respond to the Hackberry, LA site if requested.

The nominations for the Board of Directors were read for the third time. There were no nominations from the floor. There was a motion and a second to elect the nominees by acclamation. The motion carried by a unanimous vote. The new directors are: C. A. Shelton, representing the fire service, Charles Benefield, representing law enforcement, and Bill Roe, representing industry. There was a motion to retain the current officers; Ed Harris, D. A. Bruce, and Erskine Leysath for the rest of 1991, the motion carried.

Ed Harris gave a report on the last Board of Directors meeting.

The proposal to issue an award to an outstanding fire school instructor has been tabled until a formal plan can be presented to the Fire School Board for their consideration.

There were two requests for membership. The Board recommended Sabine Towing for full membership. There will be a vote on their application when their application is read for the second time at the April meeting. The Board tabled the application of Occupational Health System, Inc. for an associate membership until an opening occurs. When an opening for associate membership occurs the Board will fill the slot from those applicants that are still interested.

The Board had received a request to accept some foam concentrate on consignment. The Board decided not to accept this opportunity at this time.

A member of the SNCA, who is a CPA, has volunteered to help with the annual audits. Ed Harris and Bill Roe will decide how to best use this valuable help.

Representatives from Dooley Tackaberry, Reid Riggins and Tom May, donated six ISI Magnum 30 minute SCBA units to Lamar for use at the Fire School.

Stella Cobb reported that 143 students are registered for the fire school. This includes students from three United States Air Force bases.

The pump seal project at the training field is almost complete.

Beaumont Fire Dept. brought their ventilation truck to the meeting. All attendees were invited to visit and observe this unique piece of equipment. It will move 2000 SCFM of air and addition of a water mist will lower the air temperature at least 10 degrees F.

Ed Harris reviewed the Texas Industrial Fire Training Board's finding and recommendations concerning certification of industrial fire fighters. The responses to the questionnaires mailed to industrial organizations across the state indicates that most of them prefer some type of certification program. The TIFTB will probably recommend a program for industry that includes 72 hours of initial training and requires re-certification every 5 years. The TCC, NPRI, and TSA plan to review these recommendations for possible adoption.

Recent emergencies were discussed.

Gary Sanders with Neches Marine advised the group that they had a boat capable of pumping 10,600 GPM of fire water at 150 pounds per square inch available in Port Arthur that would respond to emergencies if requested.

Pat Shelton reported on a flash over training device that he had seen. He indicated that BFD is considering the purchase of this training devise for use at the training ground.

Captain Whiting with the USCG is leaving Port Arthur. He will be replaced by Jim Robinson.

Final negotiations are in progress to install the SAGE alerting system in Jefferson County.

The 911 telephone system is scheduled for installation this summer and should be operational by November, 1991. This system will cover Hardin, Jefferson, and Orange Counties.

There are six 1-week railroad emergency response schools scheduled this year. Contact Pat Shelton with BFD for more information.

Melvin Schmidt reported that the Chevron "Safety Train" will be available to local industry on Monday 4-15-91. There will be a morning and an afternoon session. Contact Paul Landry at 985-1663 for details.

Dooley Tackaberry will provide a fish fry for the fire school instructors at 6:30 P.M. on May 15, 1991.

Harold Burleigh reported that the Fire Field Advisory Board is making plans to install a spare fire pump at the training grounds.

There will be a Water Front Drill and demonstration in South County on April 9 & 10 involving the "Gulf Protector".

Mike Lovelady introduced Enos Cabell from the Houston Astros who enlightened everyone present about how major league baseball works today. John Williams was the winner of the drawing for a pair of Astrotickets.





Thank you for your letter, on behalf of Mr. Ed Harris, regarding the National Weather Service (NWS) Office at Port Arthur, Texas.

As Mr. Harris correctly points out, this office is among those which the NWS anticipates phasing out beginning in the mid-1990's. To become more effective and efficient in providing modern weather services to the Nation, the NWS must change the way our field offices are structured and operate. However, I can assure you that this action will not result in the degradation of essential weather services to Jefferson County. In fact, Public Law 100-685 imposes a certification requirement to ensure that operations are not degraded as a result of the transition and requires annual notification to Congress of all NWS modernization activities.

In the modernized NWS, Jefferson County will receive all warning and forecast services from the Lake Charles, Louisiana, Weather Forecast Office (WFO). This office will be equipped with a state-of-the-art Doppler weather surveillance radar and advanced computer technology. The Lake Charles office will be receiving surface weather observations from the Automated Surface Observing System which will be installed at the Jefferson County airport. This system will provide more frequent weather observations than at present for the Port Arthur area. In addition, WFO Lake Charles will program NOAA Weather Radio broadcasts and maintain communication with emergency management agencies.

We are confident that the NWS modernization will result in a better weather service. Important advances in the science of meteorology, coupled with these major new technological capabilities for observing and analyzing the atmosphere, will enhance NWS operations. The NWS of the future will use this modern technology and training to operate a highly advanced warning and forecast network.

I appreciate your interest in this matter.
