Please accept this letter of request for membership of the Beech Grove Volunteer Fire Department (BGVFD) into the Sabine Neches Chief Association. BGVFD is located in the Beech Grove Community west of the City of Jasper, in northern Jasper County, and within the boundaries of Jasper County Emergency Services District #4.

BGVFD (through contract with Jasper County ESD 4) provides fire, rescue, and medical services to a 67 square mile jurisdiction servicing approximately 2,500 permanent residents. Our response area includes B.A. Steinhagen lake (US Army Corps of Engineers), the Angelina and Neches rivers, and Martin Dies Jr. State Park.

We respond to approximately 200 calls annually and operate 2 engines, 2 tankers, 2 brush trucks, 1 high water vehicle, and 1 rescue boat with a staff of 25 volunteers. We currently operate out of one station on FM 777 at US Highway 190. Construction on a second station will begin in the 4^{th} quarter of 2023.
